Code Cases - for reopening a Chapter 7 case - \$260; for reopening a Chapter 13 case - \$235; for reopening a Chapter 11 case - \$1,000; for reopening a chapter 12 case - \$200; and for reopening a Chapter 15 - \$1,000.
