

ATTORNEY/TRUSTEE/U.S.TRUSTEE ACCESS ADVERSARY EVENTS GLOSSARY:

● **Utility/Functions Key:**

relates – ability to relate to previously docketed pleading

sched – ability to set a due date, i.e. answer, response, objection to plan, etc.

term – ability to terminate a deadline or hearing

records – screen presented that allows user to record specific information, i.e. fee information, claim information, etc.

prefix – pull-down list of prefixes displayed for inclusion in docket text, i.e. amended, joint, etc.

text – box that allows user to insert free text in docket text

flags – event will set a case flag, i.e. fees
