UPDATED COVID-19 ENTRY REQUIREMENTS FOR THE MARTIN V.B. BOSTETTER,
JR. U.S. COURTHOUSE

On January 7, 2022, the Chief Judge of the United States District Court for the Eastern District of Virginia entered General Order No. 2022-01, attached hereto as Exhibit A, which modifies the courthouse entry requirements for all members of the public, regardless of vaccination status, who wish to enter the Courthouses where the United States District Court for the Eastern District of Virginia is located, effective on January 10, 2022 (“General Order No. 2022-01”).¹ The United States District Court and the United States Bankruptcy Court share common divisional courthouse facilities in the Eastern District of Virginia except in the Alexandria Division. Accordingly, the Bankruptcy Court must address separately the policy for operations in the Martin V.B. Bostetter, Jr. United States Courthouse in the Alexandria Division (the “Bostetter Courthouse”).

On the basis of the sound reasoning articulated in General Order No. 2022-01 and in the interest of employing a consistent districtwide policy, the Court finds that mandates identical to those set forth in General Order 2022-01 should be imposed for the Bostetter Courthouse. Accordingly, it is hereby **ORDERED** that, effective immediately upon entry of this Order, all

members of the public entering the Bostetter Courthouse, regardless of vaccination status, shall be required to adhere to the entry requirements adopted by General Order 2022-01 and set forth in the public notices attached thereto, which the Court incorporates by reference.

Any member of the public seeking entry to the Bostetter Courthouse who does not comply with the aforementioned policies may be denied entry by security staff and may be asked to contact the office/chambers to be visited to determine if alternate arrangements can be made to accomplish the business needs of the visitor without entry to the Bostetter Courthouse or if an appropriate, case-specific exception can be granted by a judicial officer.

The public notice for the Alexandria Courthouse attached to General Order 2022-01 will be posted at all public entrances to the Bostetter Courthouse.

The updated entry requirements will remain in effect until further order of the Court.

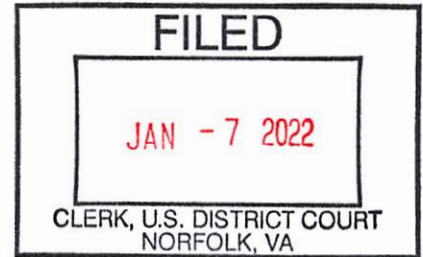

General Order No. 2022-01

The United States District Court for the Eastern District of Virginia has continued to closely monitor the outbreak of Coronavirus Disease 2019 (COVID-19), as well as the developing guidance from the Centers for Disease Control and Prevention (CDC) and state and local health authorities. Notwithstanding ongoing COVID-19 vaccination efforts, the COVID-19 Omicron variant has recently caused a meteoric rise in the number of newly identified COVID-19 cases and hospitalizations across this District and the state of Virginia.

In response to the Omicron variant, and emerging medical studies analyzing its peak periods of transmissibility, the CDC has recently updated its guidance regarding quarantine and isolation following a COVID-19 exposure or positive test. In light of such changes, and after considering the Omicron variant's increased ability to infect fully vaccinated individuals, the Court **ADOPTS** updated Courthouse entrance requirements, effective **Monday, January 10, 2022**. The updated entry requirements are set forth in the

public notices attached to the instant General Order, and they apply to all members of the public entering our Courthouses and Court facilities, regardless of vaccination status. The public notices will be posted at all public entrances to our Courthouses and Court facilities.

The updated entry requirements will remain in place until further Order of the Court based upon emerging CDC guidance and the recommendations from state and local health officials. As indicated on the updated notices, Courthouse entry requirements are subject to appropriate exceptions made on a case-by-case basis by the Senior Active Judge for the Alexandria and Richmond Divisions, and the Chief Judge for the Norfolk and Newport News Divisions.

It is so ORDERED.
