### **RULE 1017-1(C) CONVERSION**

(C) Filing of Official Form B22A-1, B22B or B22C-1 Upon Conversion of Case: Unless otherwise ordered by the Court, in a case converted from chapter 11, 12 or 13 to chapter 7, the debtor shall file Official Form B22A-1, "CHAPTER 7 STATEMENT OF YOUR CURRENT MONTHLY INCOME AND MEANS TEST CALCULATION FOR USE IN CHAPTER 7", within 14 days after conversion. In a case of an individual debtor converted to chapter 11, the debtor shall file Official Form B22B, "STATEMENT OF YOUR CURRENT MONTHLY INCOME" within 14 days after entry of the conversion order. In a case of an individual debtor converted to chapter 13, the debtor shall file Official Form B22C-1, "CHAPTER 13 STATEMENT OF YOUR CURRENT MONTHLY INCOME AND CALCULATION OF COMMITMENT PERIOD AND DISPOSABLE INCOME", within 14 days after entry of the conversion order.

1017-1(C) Paragraph (C) has been amended to conform to Official Bankruptcy Form number and name re-designations that take effect December 1, 2014. [Change effective 12/01/14.]
