EFFECTIVE DECEMBER 1, 2016

At its September 2016 session, the Judicial Conference of the United States approved inflationary adjustments to the appellate, district, and bankruptcy court miscellaneous fee schedules, as well as to the Court of Federal Claims and the Judicial Panel on Multidistrict Litigation miscellaneous fee schedules. These changes will become effective December 1, 2016. The charts included as Attachment A to this Public Notice detail the increased amounts for the various miscellaneous fee schedules. It has been five years since the various miscellaneous fee schedules last were adjusted for inflation.
